Key functions of the Project Co-ordinator:

- 1. Daily management of the CSA project.
- 2. Provide support, monitor, and evaluate the work done by the case worker on a routine basis.
- 3. Undertake visits to the homes of survivors of CSA project.
- 4. Facilitate group work for the survivors of CSA and parents and report preparation.
- 5. Facilitate life-skills education training programme for the survivors of CSA and report preparation.
- 6. Provide psychosocial care and support services to the survivors of CSA and their parents.
- 7. Undertake visits to the offices of various stakeholders (government departments, agencies, non-governmental organizations, and other entities) for networking and linkages.
- 8. Prepare monthly action plan (MAP) and Concise Monthly Progress Report (C-MPR).
- 9. Prepare detail monthly progress report (narrative) and annual project completion report (both programme and finance).
- 10. Finalize field reports case histories, case studies, and other reports prepared for the DCPU, Nirbhaya Cell, ICPS, and FDA.
- 11. Prepare any other training reports (narrative) on a timely basis.
- 12. Participate in all capacity-building training programmes.
- 13. Participate in all review and monitoring meetings called by the DCPU, Nirbhaya Cell, ICPS, and FDA.
- 14. Report to the Senior Programme Coordinator (SPC) of FDA as required.
- 15. Undertake any other project related works assigned by the SPC of FDA and the Executive Director FDA.
