- 3. Undertake visits to the homes to the beneficiaries of Kaval Plus (CSA and CNCP) projects.
- 4. Facilitate group work and life-skills education training programme for the beneficiaries of Kaval Plus (CSA and CNCP) projects and report preparation.
- 5. Provide psychosocial care and support services for the beneficiaries of Kaval Plus (CSA and CNCP) projects.
- 6. Undertake visits to the offices of various stakeholders (government departments, agencies, nongovernmental organizations, and other entities) for networking and linkages.
- 7. Ensure Monthly Action Plan (MAP) and Monthly Progress Report of Kaval Plus projects are submitted on time.
